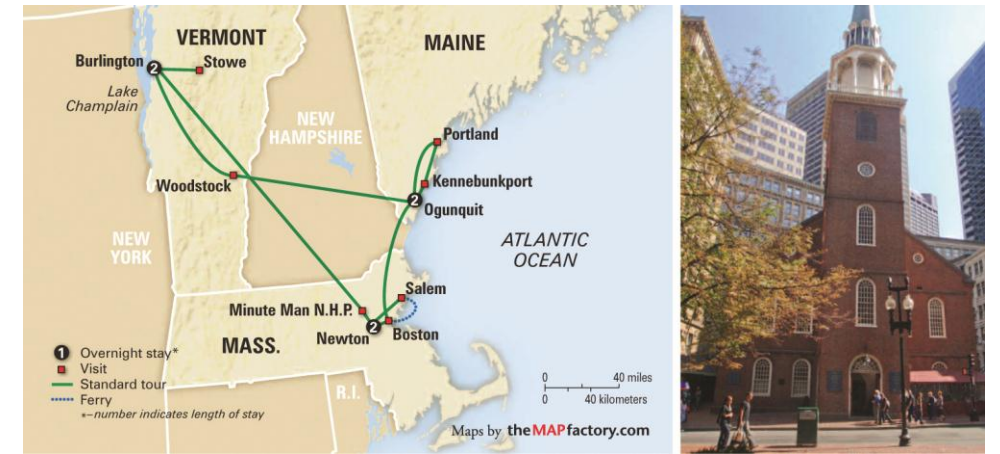

Day 1: Thursday, October 10, 2013 Boston, Massachusetts Area - Tour Begins From country stores to covered bridges and remarkable mountains, welcome to New England. Collette is pleased to offer this exciting adventure which showcases the best of New England.

Day 2: Friday, October 11, 2013 Danvers - Boston - Salem - Danvers A sightseeing tour of Boston features the Old South Meeting House, gathering place of patriots; the Public Gardens, the Old North Church, Beacon Hill, and the U.S.S.
