Please read the following and fill in immunization dates as applicable OR attach a copy of your immunization record provided by your doctor's office.

In accordance with the Oregon State Health Division, Administrative Rule 333-O50-O130, documentation of two doses of measles vaccine (rubeola) is required of all students attending Corban University half-time or more. The Office of the Registrar will be notified of students who are not in compliance with the Oregon State Health Division requirements and a hold preventing class registration for the following semester will be placed on the student's account. Questions about the immunization requirements should be directed to the Student Life Office.

REQUIRED

1. Two Rubeola (Red Measles) immunizations after 12 months of age **if you were born on or after January 1, 1957**. One is considered immune to measles only if:
 - a. One was born before 1957 (*these people are assumed to have had measles*).
 - b. One presents physician documentation of immunization with two doses of measles vaccine at least 30 days apart, on or after the first birthday.
 - c. One has been diagnosed with measles.
 - d. One can present a blood test showing evidence of immunity.
2. Rubella (*German Measles*) after one year of age.
3. Mumps after one year of age.

Most often MMR (*Measles, Mumps, and Rubella*) was given as a combination immunization at 15 months of age or later.

RECOMMENDED

MENINGOCOCCAL VACCINATION RECOMMENDATION: The CDC recommends that all first year students living in residence halls be immunized against meningococcal disease, a rare but potentially fatal bacterial infection commonly referred to as meningitis. College students living in residence halls are more likely to contract meningococcal disease than the general population due to lifestyle factors such as close living situations, irregular sleep patterns, and sharing personal items. Meningococcal vaccines should be administered before arriving at Corban.

EXEMPTION

You may be considered exempt of the immunization requirement if one or more of the following apply:

- Age Exemption: I was born before 1957 and am therefore considered immune.
- Religious Exemption: I adhere to a religion whose teachings are opposed to immunization and request that I be exempted from the immunization requirement.
- Medical Exemption: I certify that the above-named student should be exempt from the requirements for the measles vaccine based on *(Please print and have your health care practitioner fill out the below information OR attach a medical exemption from your doctor's office):*
 - History of measles
 - Immune titer shows immunity to measles
 - The following medical reason constitutes a medical contraindication in accordance with the advisory committee on immunization practices of the U.S. Public Health Services for measles vaccine:

TUBERCULOSIS SCREENING

Tuberculosis screening is **not required for students born in the United States or low-incidence countries**, as designated by the Oregon State Health Division, which include: Australia, Austria, Belgium, Canada, Denmark, Finland, France, Germany, Great Britain, Greece, Ireland, Italy, Luxembourg, The Netherlands, New Zealand, Norway, Portugal, Spain, Sweden, and Switzerland.

Students born or living for more than six (6) months outside the above countries are at higher risk of being infected with tuberculosis. Students falling into this category are required to have a TB test within 6-8 weeks upon arrival at Corban (a skin test is sufficient).

*Any students with known contact with to an individual with active tuberculosis should also be tested.

*Students with positive tests (as per CDC Guidelines) will require further testing, such as a chest x-ray, in consultation with their primary care provider.

*Any student who has had a positive TB test in the past should not be retested; these students should have a chest x-ray only and consultation with their primary care provider.

*Students must notify Student Life as soon as a positive result is confirmed.
